\_\_\_\_ 1. Authorization

The client (named above) is obtaining the services of Chris Storms Technology, located at 468 Harvest Oak Ct., Lake Mary, FL 32746, to secure a domain name, develop a web and/or transfer site, and maintain said website on a server provided by Chris Storms Technology.

\_\_\_\_ 2. Initial Set-Up

Chris Storms Technology will create/transfer the client's website free of charge and locate it on a server designated by Chris Storms Technology. In addition, Chris Storms Technology will research domain name availability. The client will be given a temporary internet address where they may view and evaluate the created website. Upon satisfaction, the client will pay Chris Storms Technology in full for the chosen package. When payment is received, Chris Storms Technology will secure a domain name and locate the website there.

\_\_\_\_ 3. Domain Registration

The client is responsible for domain name registration charges. Chris Storms Technology will assist in the purchase and set up of a domain name if requested.

If the client already owns a registered domain name, Chris Storms Technology will redirect the address to the Chris Storms Technology server free of charge.

\_\_\_\_ 4. Ownership

The client maintains ownership of the domain name. Upon request, Chris Storms Technology will provide all password information to the client.

Chris Storms Technology maintains the rights to all graphic design associated with the website, with the exception of the client's logo, motto, and any photographs provided by the client and any website features created prior to transfer to Chris Storms Technology. Should the client choose to move their website to another server, it is their responsibility to make reasonable changes to the website design.

\_\_\_\_ 5. Graphic Design

Chris Storms Technology must receive all necessary logos, photographs, and text from the client, in order to complete the client's website. Chris Storms Technology will scan any photographs and logo designs used in the website at no additional cost to the client.

\_\_\_\_ 6. Hosting Contract Renewal

This contract is perpetual and may be renewed annually for \$64.99. Chris Storms Technology will maintain the client's website on a server used by Chris Storms Technology for one year with the initial fee. No earlier than thirty days prior to this contract expiration date, Chris Storms Technology will send an invoice to the client with payment details for the next calendar year. The client is responsible to pay in full by one year from this calendar date. Failure to do so will result in termination of website on the server used by Chris Storms Technology.

\_\_\_\_ 7. Cancellation

Should a client desire to cancel this agreement for any reason after 30 days from contract date, any annual payments are forfeited. Chris Storms Technology will provide the client with all necessary information to move the website to another company's server. Cancellation requests must be in writing.

\_\_\_\_ 8. Guarantee

The client has 30 days from the date of this contract to request changes to the website, to include changes in text, color scheme, logos & photographs.

In addition, should the client decide within 30 days from the date of this contract that the website is unsatisfactory, Chris Storms Technology will provide a complete refund with the exception of the amount paid for domain name registration.

\_\_\_\_ 9. Maintenance – Webmaster Services

After 30 days from this contract date, Chris Storms Technology will, at the request of the client, make changes and updates to the website at a rate of \$14.75 per ¼ hour. Requests for updates may be made via e-mail or phone. Chris Storms Technology is solely responsible for doing maintenance/updates to websites located on the Chris Storms Technology used server.

\_\_\_\_ 10. E-mail

The client will receive up to 5 e-mail addresses to be associated with the website. Additional e-mail accounts may be purchased for a one-time \$3 fee.

\_\_\_\_ 11. Website Completion

Chris Storms Technology will work with the client to complete all work within 30 days of receipt of all text, photographs, and logo images and/or previous server passwords.
